- (1) Street naming for Timberlea site The Clerk will advise the developer that 'Birch Close' is the preferred name
- (2) End of year audit it was noted that the external auditors, PKF Littlejohn, have signed off the 2021/22 accounts
- (3) Millwood building works two new large wooden buildings have been constructed clerk to find out if planning permission is required

- (4) Longfield House planning concerns Broadland District Council have advised that owner needs to submit retrospective planning permission
- (5) **Thank you** the Parish Council and especially the Clerk, would like to say thank you to everyone who has helped around the village this summer with litter collection, the playground, bins and cones etc
- (6) Road Safety Conference 21 September Approval was given for for Mr C Jones to attend and claim travel expenses
- (7) Road Safety Community Fund (RSCF) In Cllr Whymark's absence the Councillors decided to investigate this further.
- (8) Cycling events Mr Kirby raised concerns about cycling events using Mill Road on busy weekends. The clerk to ask what procedures organisers need to follow and who they need to consult.
- (9) **Community at Heart Awards** Mr Kirby to forward details to clerk to nominate the Horstead Centre.

8. Highways & PROW

- (1) B1150 Special Interest Group Cllr Copplestone talked about the Terms of Reference. Approval was given for Mr Jones and Mr Kirby to be the Parish Councils representatives. The clerk will attend and minute two meetings a year.
- (2) FP7 Mill Road to Green Lane overgrown Mr Jones has reported
- (3) **Ms Weightman will report the following issues:** Various road signs hidden by hedges. At Heggatt SLOW road signs have virtually disappeared.

10. Horstead Mill

- (1) Fishing line recycle posts Mr Kirby reported that these were installed at the end of August
- Bottle banks these were discussed and it was decided not to pursue this idea at the current time due to concerns about broken glass and that it would take up a car parking space,
- (3) Fallen tree on Mill Road opposite Mill car park access Mrs Fleming reported that Cadent now has the Road closed to carry out gas repair works. Mrs Fleming will arrange for the branches cut by BT to be cleared away. Several properties were without internet access for about 4 weeks until the line was re-installed.
- (4) Ash dieback tree BA/2020/0402/TCAA The clerk has asked the Broads Authority if they have carried out their follow up inspection as recommended back in 2020 and if not when will this take place, Highways have also reported that they are concerned about the state of this tree Awaiting response from the Broads Authority
- (5) **Fundraising** the final draft of the sign designs were approved. The Clerk, Mr Browne and Mr Jones will get together to set up a QR code.

11. Playing Field

- (1) Inspections are being carried out weekly by Mr Jones and reported on the community Facebook page.
- (2) Bird spikes an incident occurred in July where the bird spikes were removed and dispersed around the playground. Mr Jones and Mr Hales have now glued as well as tied them in place to hopefully prevent further incidents
- (3) Ash Tree Mr Jones has reported that an Ash tree at the Mill end of the playground hasn't shown any signs of life this summer We are currently waiting for the landowner to inspect the tree.
- (4) Large slide it has been reported that the handle is starting to disintegrate. Mr Jones has taped this up, but it was agreed that the clerk will obtain quotes to remove the slide and then to replace it,
